## **Dispute Resolution Experience**

- Represented Canxing in "The Voice of China" trademark infringement and unfair competition disputes with Talent, which attracted much public attention due to the show's reputation and the attribution of program name rights.
- Represented China State Construction Engineering Corporation in a dispute with Zhongjian Investment Holdings Co Ltd for trademark infringement and unfair competition. This case involves a major Chinese SOE, which did not register a relevant trademark, and a bad faith trademark registrant. In their judgment, the Beijing IP Court recognized the relevant unregistered and registered trademarks as well-known trademarks and granted damages as claimed.
- Represented Chukong in the second instance trial of a dispute involving gaming software infringement and unfair competition. During the first instance proceedings, Guilin

Intermediate People's Court awarded damages of RMB70 million against Chukong, which was then the highest award for game infringement in China. After the second

instance trial, Guangxi High People's Court annulled the first instance judgement and

remanded the matter for retrial. With the help of Ms Zhang's team, the two parties

reached an agreement, and our client avoided huge economic loses.
